Office order

In Supersession of this Directorate letter of even Number dated 24 – 11 - 2011 on the subject cited above , it has now been decided that All the Dy. Directors of Higher Education in Himachal Pradesh are hereby authorized & delegated the powers to sanction the GPF withdrawal (Non Refundable) from the GPF Account in respect of Officers/Officials who were working under their administrative control before proceeding on deployment on secondment basis and presently working on secondment basis in Sarva Shiksha Abhiyan,/ RMSA/ H.P.Board of School Education ,Dharamsala or in any other organisation under Rules - 12 (2) and 15 of the General Provident Fund (Central Services) Rule 1960.

All these Sanctioning Authorities will be responsible for proper adherence of the rules and in the cases of negative/minus withdrawal/balance, they will be held responsible for such lapse and these will be termed as temporary embezzlement inviting both Departmental as well as criminal action. In order to avoid the occurrence of negative/minus withdrawal/balances from the GPF Accounts of the subscribers, the detail of each advance/withdrawal sanctioned to an employee should be recorded invariably in the original annual statement and advance/withdrawal shall be sanctioned on submission of original GPF statement only.

These orders will come into force with immediate effect.
