Sir,

Your Kind attention is drawn to Directorate of Elementary Education's letter No No.EDN. (H) (Pry) 4 (4)1/A.W/2009-10.dated 19-10-2009 vide which you were requested to send the name of two students (one from class 6th - 8th in group A and one from class 9th or 10th in group B who have got highest marks in science subject) and also prefer one student from group A or B who has secured the highest percentage in science subject. All the Deputy Directors of higher/ Ele. education in H.P. were also requested vide Directorate of Elementary Education H.P.'s. letter No. even dated 12 .11.2009 , 12.7.2010 & 3-2-2011 for sending the name of two such children from each school under Scheme for Early Attraction of talents for science (SEATS) " INSPIRE" Awards to school students. But it is a matter of great concern that inspite of repeated request and reminders, neither the heads of high/senior secondary schools nor Deputy Directors of higher education took pain to supply the requisite information uptill now. As a result of which directorate of elementary education is facing hardship at the centre level due to non-supply of the consolidated information of the state. As the government has taken a serious view for non-submission of information, you are hereby offered an opportunity to supply the requisite information to Sh. M.L.Azad, Deputy Director-cum-Nodal officer, INSPIRE Award scheme Directorate of Elementary Education Himachal Pradesh Shimla-1 on or before 5-3-2011 positively so that consolidated information of the state could be submitted to government of India failing which disciplinary action will be got initiated against the defaulter heads of high/SSS and their salary for the month of March 2011 shall not be paid to the Principals/ Headmasters of the concern school and the amount of award be recovered from the salary of the defaulters i.e. Principal's/ Headmasters. This information is also available on departmental website www.educationhp.org.
