Subject:- Regarding rescheduling of Vacation, Admission and  
Examination schedules of Govt. colleges in the State.

Sir,

I am directed to refer to your letter No.EDN-H(21)A-  
(3)5/2010-V dated 14-01-2011 on the subject cited above and to convey the  
approval of the Govt. for Vacation, Admission and Examination schedule of  
Govt. Colleges in the state as under:-

**Uniform-Vacation schedule of Colleges:-**

- i) 2<sup>nd</sup> May to 31<sup>st</sup> May = 30 days.
- ii) Festival Break starting from 4 days before Diwali upto six days = 6 days.
- iii) 1<sup>st</sup> January to 29<sup>th</sup> January = 29 days.

Total = 65 days

**Admission Schedule:**

- i) 1<sup>st</sup> June to 10<sup>th</sup> June without late fee = 10 days.
- ii) 11<sup>th</sup> June to 20<sup>th</sup> June with late fee of Rs.10/- per day. After this no  
admission in any case will be given except if there is any statutory provision  
in this regard and the regular teaching work will commence on or before  
11<sup>th</sup> June positively.

**Examination Schedule (For Current Year):**

- i) Practical examination will commence from 1<sup>st</sup> March to 15<sup>th</sup> March (all


faculties start with B.Sc.IIrd.at first).

ii)Theory paper of all faculties will commence from 15<sup>th</sup>.March to 26<sup>th</sup> April(all faculties start with B.Sc.IIrd. at first).


Further,examination schedule is approved with the condition that In future,Practical examination will be conducted in the month of March and theory examination will be conducted in the month of March and April,keeping in view the appropriate gaps in various papers as per requirement of students.

You are,therefore,requested to take necessary action in the matter.It is further requested to issue necessary instructions to all Colleges in the State to spare their teachers for practical and theory examinations as well as for the evaluation,for smooth conduct of exams and declaration of results and all the college teachers(regular & Contract)will give duty for exams as well as for the evaluation.However, preference should be given to the experienced teachers.Any teacher who does not attend the duty,once ordered by the Principal or any authorized officer of University, will be treated as absent on that day.


